Terms defined in the Ultra Electronics Holdings plc scheme circular dated 8 September 2021 (the "Scheme Document") shall apply equally in this Form of Proxy, unless the context otherwise requires. Full details of the resolution to be proposed at the Court Meeting, together with explanatory notes, are set out in the Notice of Court Meeting. Before completing this Form of Proxy, please also read the sections entitled "Action to be Taken" set out on pages 11 to 15 of the Scheme Document. - 2. The Court has appointed Tony Rice or, failing him, Simon Pryce, or failing him, any other Ultra Director to act as Chairman of the Court Meeting and has directed the Chairman to report the result thereof to the Court. Scheme Shareholders will also be given the opportunity to attend, submit questions and/or any objections and vote at the Court Meeting via a virtual meeting platform provided by Lumi AGM UK Limited ("Lumi") (the "Virtual Meeting Platform"), further details of which are set out in Explanatory Note 3 below and on pages 2 and 3 of the Scheme Document.
